## Skilled Nursing Facility (SNF) Revalidation

The Medicare Enrollment Application - Institutional Providers (CMS-855A), 09/24 version, includes a new section, New Attachment 1: Skilled Nursing Facility Ownership Disclosures. This attachment collects information for CMS regarding SNF ownership, managing control and Additional Disclosable Parties (ADP).

With the release of this CMS 855A (09/24), CMS is revalidating all enrolled Skilled Nursing Facilities (SNF) to collect the information contained in the new attachment.

MACs sent revalidation request letters to enrolled SNFs between October and December of 2024. SNFs have until May 2025 to comply with the revalidation requests.

CMS will not be updating the Medicare Revalidation List (<a href="https://data.cms.gov/tools/medicare-revalidation-list">https://data.cms.gov/tools/medicare-revalidation-list</a>) to reflect these off cycle SNF revalidations.

## **Annual Wellness Visit (AWV)**

AWVs are an opportunity for healthcare providers to gather important information regarding their patient's health and make recommendations when needed. The AWV is a service available at no cost to beneficiaries entitled to Medicare Part B for at least 12 months.

Annual Wellness Visits can be delivered through telehealth. This requirement can be met through telephone-only interaction.
